

Terms and conditions Leiden University SCOOCs platform

To be accepted by all participants

1. Terms

1.1 These Terms govern your access to and use of Leiden University SCOOCs platform, and any information, text, graphics, photos or other materials uploaded, downloaded or appearing on Leiden University SCOOCs platform ("Content").

1.2 Your access to and use of the Services is conditional on your acceptance of and compliance with these Terms. By accessing or using the Leiden University SCOOCs platform you agree to be bound by these Terms.

1.3 These Terms may change from time to time without notice and you should consult the Terms each time you use Leiden University SCOOCs platform in order to view the most current terms. All references to the Terms mean the current version of the terms at the time of your use.

1.4 We process information about you in accordance with our Privacy Policy which forms part of these conditions and in accordance with the Privacy Statement of Universiteit Leiden.

2. Registration and security

2.1 You will not provide any false registration or account information about yourself and/or your organization and will not create an account for anyone other than yourself.

2.2 You will not use Leiden University SCOOCs platform if you are under 13.

2.3 You will not share your password with anyone or do anything that would put the security of your account in danger.

2.4 We have the right to cancel any account at any time if we believe you are not in compliance with any or all of the terms.

3. Your use of Leiden University SCOOCs Platform

3.1 You must not use Leiden University SCOOCs Platform or any facilities or information which are available through it to:

- a. commit or encourage unlawful acts or acts which breach of these terms of use;
